A BILL

To modify certain definitions under the Export Control
Reform Act of 2018.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Addressing Dangerous
5 Vulnerabilities in Exports and Research to Strategic Ad-
6 versaries, Regimes, and Industrial Entities of Security
7 Concern” or the “ADVERSARIES Act”.

1 **SEC. 2. MODIFICATION TO DEFINITIONS UNDER THE EX-**
2 **PORT CONTROL REFORM ACT OF 2018.**

3 Section 1742 of the Export Control Reform Act of
4 2018 (50 U.S.C. 4801) is amended—

5 (1) in paragraph (5)—

6 (A) by striking “means—” and all that fol-
7 lows through “(A) any natural person” and in-
8 sserting the following: “—

9 “(A) means—

10 “(i) any natural person”;

11 (B) by adding “or” at the end of clause (i)
12 (as so designated);

13 (C) by striking “(B) any corporation” and
14 inserting the following:

15 “(ii) any corporation”;

16 (D) by striking the period at the end of
17 clause (ii) (as so designated) and inserting “;
18 or”; and

19 (E) by adding at the end the following:

20 “(B) includes—

21 “(i) each entity identified pursuant to
22 section 1260H(a) of the William M. (Mac)
23 Thornberry National Defense Authoriza-
24 tion Act for Fiscal Year 2021 (10 U.S.C.
25 113 note) to be a Chinese military com-
26 pany;

1 “(ii) each entity identified pursuant to
2 Supplement No. 4 to part 744 of title 15,
3 Code of Federal Regulations, or successor
4 regulations by the Bureau of Industry and
5 Security of the Department of Commerce;

6 “(iii) each entity identified pursuant
7 to Supplement No. 7 to part 744 of title
8 15, Code of Federal Regulations, or suc-
9 cessor regulations by the Bureau of Indus-
10 try and Security of the Department of
11 Commerce;

12 “(iv) each subsidiary or affiliate of an
13 entity that is owned 50 percent or more in
14 the aggregate, directly or indirectly, by an
15 entity described in clause (i), (ii), or (iii),
16 wherever located.”; and

17 (2) in paragraph (6), by striking “foreign”.
